	Coverage period	All children registered in the CRANE Database with a date of birth within the reporting year (refreshed every calendar year) <sup>1</sup> .
	Exclusions	Scotland and Northern Ireland registrations.
	Numerator	Number of consented <sup>2</sup> children with Cleft lip and/or Palate, born in the designated year, who at the age of 5 years and before they are 6 years of age have dmft scores recorded by an appropriately calibrated paediatric dentist.
	Inclusions [Numerator]	(a) All consented children who are alive at five years of age. (b) All cleft types, including unspecified ones <sup>3</sup> . (c) All children without submucous cleft palates. (d) Children with dmft data recorded in CRANE before the age of six years.

	Denominator	Total number of (5 year old) consented <sup>2</sup> children with Cleft lip and/or Palate, born in the designated year, who are recorded on CRANE.
	Inclusions [Denominator]	(a) All consented children who are alive at five years of age. (b) All cleft types, including unspecified ones <sup>3</sup> . (c) All children without submucous cleft palates.
